

The Chittoor district administration declared on Monday that calcium carbide (CaC₂), which is typically used to artificially ripen the fruit, would be prohibited during the height of the mango season. Speaking to the media here, Joint Collector G. Vidyadhari cautioned the farmers, vendors, and traders that it is illegal to sell calcium carbide or transport or store it. India will protect farmers' interest in U.S. trade talks: Shivraj Singh Chouhan

India will prioritise protecting its farmers' interests while assessing potential gains and losses in the ongoing trade negotiations with the U.S. over agricultural market access, Union Agriculture Minister Shivraj Singh Chouhan said. "Our priority is to protect the interest of our farmers. India will not work closing its eyes. We will assess our gains and losses. Keeping that in mind, an agreement will be finalised," Mr. Chouhan told the PTI in an interview.



Delays in Insurance Claims to Attract 12% Interest, Says Agriculture Minister During VKSA Outreach in Sehore

Union Minister Shri Shivraj Singh Chouhan has announced a reform aimed at strengthening the Pradhan Mantri Fasal Bima Yojana (PMFBY) in India. Delays in disbursing crop insurance claim payments will attract an additional 12% interest from insurance companies, ensuring farmers receive timely compensation for crop losses. The Viksit Krishi Sankalp Abhiyan (VKSA) initiative aims to build a unified and modern agricultural system across India. Chouhan also highlighted welfare schemes, including the Pradhan Mantri Awas Yojana, which has distributed 8 lakh letters of acceptance for new houses.



Export-import policy must protect farmers' interests

PM-Kisan 20th Instalment: Will farmers get their next payment this month? Check latest update

The 20th instalment of the PM Kisan Samman Nidhi Yojana (PM-KISAN) is expected to be released this month, providing financial support to crores of Indian farmers. The scheme, launched in February 2019, offers Rs 6,000 per year, split into three equal instalments of Rs 2,000 each, through Direct Benefit Transfer (DBT) mode. The 20th instalment is expected to be disbursed in June 2025. To receive the instalment, farmers must have an e-KYC done, have Aadhaar linked with their bank account, and match names in both Aadhaar and bank records.



Indian tea prices rise 18% as demand surges from Russia, Iran, Iraq and UAE

Indian tea prices have surged by 18% in the first four months of this year. This is due to high demand from Russia, Iran, Iraq, and the UAE. Exports are expected to remain strong. Major consumer goods firms are increasing purchases. Auctioneers anticipate prices to stay firm. Packet tea sellers are hesitant to raise prices for local consumers.



Odisha mangoes now in France, Belgium as exports soar

Odisha has expanded its agricultural exports by adding France and Belgium to its mango export destinations. This success builds upon existing markets like Dubai and London, with exports nearing 100 MT since May 2024. Farmers are benefiting from 40-60% higher prices due to direct export access and improved quality, solidifying Odisha's position as a growing agri-export hub.


India's agri sector transformed by five-fold budget surge over 11 years: Govt

Immigration Raids Spread to Agriculture as Meat Plant Targeted.

Immigration raids targeting farm workers are spreading across cities, including the agriculture industry. Over 70 people were detained in a US Immigration and Customs Enforcement raid at a meat plant in Omaha, Nebraska, and a field where farm laborers were picking blueberries in Tulare County, California. The Trump administration is ramping up immigration raids across the country, with nearly half of the US's 850,000 crop workers being undocumented. California's largest agricultural state has seen federal agents in farm fields and packinghouses, raising concerns among Democratic Senators Alex Padilla and Adam Schiff. SOURCE- LIVEMINT.COM



Upcoming kharif crop area estimates to be fully based on satellite data.

The first advance estimates for kharif acreage this year, likely to be released in September, will be based on satellite data, eliminating the traditional manual 'girdawari' system for calculating crop area, sources told Business Standard. "In our pilot studies, the results have shown accuracy in the range of 93–95 per cent, which is considerably higher than the manual method. Starting September, we will release fully digital acreage data for kharif crops," the sources said. The Ministry of Agriculture and Farmers' Welfare is working to improve crop area estimation by fully digitising the process across all districts using satellite-based data. India Pushes Back On US Trade Demands Over Agriculture, Dairy And Digital Services Ahead Of Tariff Deadline.

India-US bilateral trade negotiations are entering their final phase, with discussions becoming increasingly complex due to sensitive issues in dairy, agriculture, digital, and medical services. The US is pushing aggressively to open these sectors, while India seeks a more equitable agreement that protects domestic priorities. Negotiations are expected to continue virtually, with both sides aiming to finalise an agreement before the expiry of a 90-day pause on reciprocal US tariffs. A major sticking point remains US dairy exports, with India reluctant to liberalize due to social sensitivities and potential market disruptions. The US approach veers from the joint pledge for a "mutually beneficial" trade pact by autumn 2025. SOURCE-SWARAYA.MARG.COM



Kerala Economics and Statistics dept report pegs average monthly income of agricultural households at ₹28,984.

The average monthly income of agricultural households in Kerala, while showing an increase over 2019, continues to hover below the ₹30,000-mark, indicates a report compiled by the Economics and Statistics Department of the Kerala government. The average monthly income of agricultural households, at current prices, stood at ₹28,984 in 2024, according to the Situation Assessment Survey of Agricultural Households in Kerala: 2024-25, compiled by the department in collaboration with the Agriculture Department. Of this, crop production by itself accounted for a mere 22.97% (₹6,658), with the rest being contributed by wages (60.71%), animal farming (6.25%), non-farm business (9.93% and income from leasing out land (0.13%). In addition to these sources, the earnings from pensions and remittances stood at ₹6,348. SOURCE-THE HINDU

The ministry will release its final estimates of agricultural crop production for 2024-25 in September 2025. The initiative will use satellite-based data, which is 95% accurate compared to traditional surveys, to revolutionize crop area estimation across the country. The ministry plans to release the first-ever comprehensive satellite-based crop estimates in September 2025, including production data for crops, marking a significant leap forward in agricultural data collection and analysis for the country. The ministry began testing satellite-based data for estimating crop area in 2024 and conducted a survey under the Digital Agriculture Mission (DAM) last year to prepare the estimates.
